

LAST WILL AND TESTAMENT

OF CONNIE DEL POZO

I, **Conie Del Pozo**, born on **July 25th, 1943**, residing at **1880 Boston Road Apt. 901, Bronx, NY 10460** being of sound mind and memory, declare this to be my Last Will and Testament.

1. Revocation

I hereby revoke all prior wills and codicils previously made by me.

2. Identification of Children

I have two children:

- **Marisol Concepción Del Pozo Del Pozo**
- **Jorge Del Pozo Del Pozo**

I intentionally make provision in this Will only for **Marisol Concepcion Del Pozo Del Pozo**.

I intentionally and deliberately make **no provision** in this Will for my son, **Jorge Del Pozo Del Pozo**.

3. Sole Beneficiary

I give, devise, and bequeath my entire estate, including **all property, assets, rights, and interests that I own at the time of my death or to which I may be entitled**, entirely and exclusively to my daughter:

Marisol Concepción Del Pozo Del Pozo

This includes all bank accounts, financial assets, personal property, and any other interests belonging to me.

4. Inheritance From My Sister

I specifically include any inheritance, funds, property, claims, or rights arising from the estate of my sister, **María Camila del Pozo del Pozo (DNI: 09788724Q)**, in whose Will I am named as a beneficiary, including any rights or interests **to which I am entitled in that estate**, whether or not I have formally accepted the inheritance at the time of my death and regardless of whether the estate remains under administration or distribution at that time.

If I die before receiving any distribution from the estate of my sister, **all rights or interests that belong to me from that estate shall pass directly and entirely to my daughter, Marisol Concepción Del Pozo Del Pozo.**

5. Executor

I appoint **Marisol Concepción Del Pozo Del Pozo** as Executor of this Will.

If she is unable or unwilling to serve, the Surrogate's Court of the State of New York may appoint an administrator to carry out the terms of this Will.

6. No Contest Clause

If any person, including any heir or beneficiary, directly or indirectly contests this Will or seeks to challenge its validity or provisions through legal action, **that person shall receive no part of my estate.**

7. Intent

It is my clear and express intention that **Marisol Concepción Del Pozo Del Pozo receive one hundred percent (100%) of my estate**, including all present property, financial assets, inheritances, and legal rights to which I may be entitled.
